#### Yokohama City Tax: **Deferment of Payment** (New Coronavirus Infectious Disease Related)

If you have difficulty paying Yokohama City Tax because of the influence of new coronavirus infectious disease, the payment might be deferred. Consult with your local ward office, tax section. #### Special Cash Payments of 100,000 yen

Due to the Coronavirus (COVID-19), the Japanese government is giving 100,000 yen as Special Cash **Payments** (Tokubetsu Teigaku Kyufukin)

to each person living in Japan. Foreign residents can receive this money too.

Eligibility: Those people who have their name on the Basic Resident Resister on April 27, 2020. \*A residence card (Status of residence) that lets you live in Japan for more than three months. A residence certificate registered with your town or city (municipality).

To Apply: Fill out and submit the application form which is sent to the householder. On the application form, you need to write the bank account you want the money paid into. You also need a document that certifies the bank account and a copy of a document that shows your identity. \*If the householder has MyNumber (Individual Number) card, you can apply online. #### **Supplementary Income Payment for Child Rearing Families**

To support child rearing families who are affected by new coronavirus infectious disease, Supplementary Income Payment will be given to those who are receiving Child Allowance (household of children from 0-year-old up to Jr. HS students). The payment starts gradually from

Eligibility: Household of children who were born between April 2, 2004 and March 31, 2020. \*Household which exceeds the income-limit and receiving 5,000 yen a month per child of Child Allowance is NOT eligible to receive this supplementary income payment.

Allowance: 10,000 yen/child **To Apply:** If you are not a public servant, you DO NOT need to do any special application. It will be sent to your bank account registered for your Child Allowance.

#### **Sickness Allowance for National Health Insurance** Member (New Coronavirus Infectious Disease Related)

If you are a member of National

Health Insurance who has not received enough salary from your employer



because of your being infected or being suspected of having the new coronavirus infectious disease, and you have to take time off work. sickness allowance will be provided.

Eligibility: Those who meet all of the following 4 conditions:

- (1) A member of Yokohama city National Health Insurance who is a salary-paid worker
- (2) A person who has to take time off work because of being infected or being suspected of having the new coronavirus infectious disease
- (3) A person who has missed work continuously for 3 days and has missed work either on the 4th day or any day(s) after, and the 4th day

(4) A person whose salary has not been paid or is partly reduced.

**Period of Payment:** Period you were planning to work but couldn't. It starts 3 days after the day you can't work. \*for the maximum of 18 months

**Allowance:** (The net total of the latest continued 3 month-salary ÷ working days) x 2/3 x days \*When your salary is partly paid and/or other compensation benefits are being paid, this allowance could be reduced or won't be provided.

\*There is the upper limit for this allowance.

**To Apply:** Fill out the application forms and submit them to your local ward offices.

\*There are forms your employer and your doctor need to fill out as well.

# **Subsidy Program for Sustaining Business**

Many businesses expect a decline in revenue because of the new coronavirus infectious disease outbreak. The Japanese government is going to provide subsidies to struggling companies and sole proprietors/individual businesses.

Eligibility: Businesses have to meet the following requirements: 1. Businesses' sales decreased by 50% or more compared with the same month of the previous year by the influence of new coronavirus infectious disease. 2. Businesses had sales before

2. Businesses had sales before 2019 and are willing to continue their business

3. For companies whose capital is less than 1 billion yen or the number of regular employees is 2,000 or less

**Subsidy:** Subsidy amount is whichever is smaller of the two below:

- (1) Sales decline from last year as calculated by the following formula.
- (2) Upper limit: 2 million Japanese yen for the small-medium

enterprises or 1 million Japanese yen for sole proprietors/individual businesses.

Formula of the Sales decline is as follows:

Sales decline = Sales amount of last year - (Sales of a month 50% or more declined against the same month last year X 12)
