Financial Assistance for the Disabled

 Welfare Allowance for Disabled Children (up to 20 years old)
(Shogaiji Fukushi Teate) & Special Allowance for the Disabled (over 20 years old) (Tokubetsu Shogaisha Teate): For severely disabled people who need nursing care in everyday living.
(2) Special Child Support Allowance (Tokubetsu Jido Fuyo Teate): For guardians who raise children (under 20 years old) with disabilities.

For all allowances: *Income restrictions apply. *Those who live in disabled people's facilities are not eligible. Applications are accepted anytime at Ward Offices' Health and Welfare Centers. Other restrictions apply, so please check with your local ward office about the details.

Notice from the Ministry of Health, Labour and Welfare

Even when the new coronavirus (COVID-19) has caused a decrease in business for a company, foreign workers are not allowed to be treated less favorably than Japanese workers just because they are foreigners.

 (1) Companies must pay a leave allowance to foreign workers as well as Japanese workers when they are forced to take days off from work by the company.
(2) The subsidy the national government pays companies to protect workers can be used for foreign workers as well as Japanese workers.

(3) When foreign workers take days off from work because their child's school is closed, they can take **paid leave** just like Japanese workers.

(4) Companies cannot fire foreign workers freely. When a company intends to fire their workers, **the same rules should apply for both Japanese and foreign workers.**

COVID-19 Related Support Measures for Individuals <Benefit>

■Special Cash Payment (*Tokubetsu Teigaku Kyufukin*) The Japanese government is giving 100,000 yen as a Special Cash Payment to each person living in Japan. Foreign residents can receive this money too. Eligibility: Those people who have their name on the Basic Resident Register on April 27, 2020

Supplementary Income Payment for Child Rearing Families

10,000 yen/child will be given to those who are receiving Child Allowance.

Eligibility: Households of children who were born between April 2, 2004 and March 31, 2020. *Households that exceed the income-limit and receiving 5,000 yen a month per child of Child Allowance are NOT eligible to receive this supplementary income payment.

*You DO NOT need to do any special application. The payment will be sent to your bank account registered for Child Allowance. **Inquiries:** Child and Youth Bureau, Child and Family Division (045) 641-8411 (*J) Fax (045) 641-8412

■Supplementary Income Payment for Single-Parent Families

20,000 yen/a household will be given to those who are receiving Child Rearing Allowance. **Eligibility:** Single-parent household receiving Child Rearing Allowance

*You DO NOT need to do any special application. The payment will be sent to your bank account registered for your Child Rearing Allowance.

Sickness Allowance for **National Health Insurance** Member

Eligibility: A member of the National Health Insurance who meets all of the conditions (1) Salaried worker, (2) has to take time off work because of being infected or suspected of being infected with COVID-19, and (3) salary hasn't be paid or has been reduced.

Eligibility: People who have lost their residence or are at risk of losing their residence as the result of losing their job, have lost their business, or have seen their income decrease

Safety-Net Housing with Rent Subsidy

For people who are living in a

Eligibility: Those who are struggling with filing

(declaring) and paying tax Those who haven't filed (declared) residential tax, contact your local ward office, tax division, or municipal tax section.

For those who have difficulty filing (declaring) for income tax, gift tax, and consumption tax by unincorporated enterprise, the due date might be postponed. Contact your local Taxation Office.

Those who have difficulty paying residential tax, contact your local ward office, tax division, premium collection section. *For Prefecture Tax, contact your Prefecture Taxation Office. *For National Tax, contact National Tax Agency at 0120-948-271 (*J)

Eligibility: Those who are
